

## **CEO's Message**

The financial year commenced with a sense of renewed energy in membership stability and engagement notably through the Members' Lounge and community platform; interest in and exploration of current and new professional learning programs and services; a renewal of branch executives and presidents through nominations and elections; and new developments related to partnerships and publications.

ACEL's identity is built on the generosity of our profession and those volunteers who give of their time, expertise, energy, and wisdom to ensure that education in Australia goes from strength to strength. That strength lies in the depth of our diversity, increasingly obvious as we consider the expertise that resides in our branches around the nation. We continue to be encouraged by the momentum in participation of our local events that provide meaningful learning opportunities for our members to learn with and from each other. This learning and leading mindset and a belief in our education community are underpinned and aligned to our five national pillars showcased throughout this report.

ACEL's key priority areas are centred around financial robustness and sustainability, diversity and inclusiveness, and determining the way in which ACEL can contribute as a voice for the profession. Research and commentary regarding the landscape of professional associations profile how the dynamics of member behaviour and expectations have undergone a profound transformation. The rising costs of doing business, the impact of a higher cost of living on spending, together with uncertainty around interest rates, have had an impact on small business confidence. This shift has not only challenged the status quo but has also posed a challenge to traditional revenue streams requiring ACEL and other professional organisations to assess the current climate, identify challenges, and illuminate potential and diverse opportunities for growth.

Our proactive retention and engagement strategies have included leveraging and improving perceptions of membership value through ACEL's wealth of media content and resources free to access for all members through to launching and energising Educhat and NextGen initiatives with interest and participation continuing to grow. We are keen to have these initiatives led by recipients and members, who may be prepared to take on a leadership role with support of the national office. Other key areas ACEL focused on include the national and state/territory awards that constitute a key plank in recognising excellence in educational leadership in Australia. Through a commissioned review, the ACEL Board continues to support and refine the awards, with recommendations elevating the nominations as well as a refreshed marketing strategy where award recipients are representative of the diversity of our profession.

Our business model is shifting from a reliance on short-term professional learning activities to a focus on strategic, long-term program development. By timely monetising assets, and securing income through high-performing term deposits, we concluded the financial year well-positioned to propel ACEL into the future. Moving away from a dependence on advertised, one-off events allows us to concentrate on developing a responsive, personalised service model, with greater efficacy, impact and sustainability. This approach began with the launch of the ACELearn platform creating strategic and dynamic possibilities for ACEL to leverage and grow a suite of high quality professional learning opportunities regardless of sector or location. Public, bespoke and network options amplify our agility in responding to identified learning needs with a consistency of support to jurisdictions, sectors, networks, and schools. These network options also expand our reach and services beyond leaders to include teachers. Through ACELearn Co-labs, a fresh approach to professional learning has been established involving educators across and between schools working together enhancing collegiality, teacher agency, and data informed practices. ACELearn emphasises connection,

collaboration and co-construction of professional learning programs enabling us to share the depth of expertise that resides within ACEL to cross-fertilise/promote with our current (untapped) resources.

Together with the guidance and expertise of the ACEL Board, led with equanimity by our insightful President, Dr. Briony Scott, the exceptional experience and work of the Audit and Risk Committee has provided a high level of critical oversight and advice to both Board and Management. The national office team and project managers have diligently fulfilled their roles, capitalising on initiatives and the strong momentum of engagement across the organisation. Their unwavering commitment to excellence has been consistently acknowledged, with the most outstanding feedback recognising their remarkable responsiveness and dedication to fostering a culture of service.

ACEL's 50th Anniversary Conference ignited an exciting and transformative year, marked by outward-facing improvements and enhanced communication and engagement processes. As we embed new initiatives into our delivery models and program development, we are already seeing promising growth. Though challenges will always arise, the rewards are inspiring and deeply impactful. ## **Leadership and Learning**




Despite the continuous challenge of teacher shortage across the education community, those who were able to participate in our events provided positive feedback and took away valuable insights that they can share with their wider network.

As a part of the inaugural NextGen initiative, I had the privilege of learning so much; getting up close and personal with legends who generously shared their insights and wisdom, providing invaluable guidance for the journey ahead. The 50th anniversary of this organisation reminded me of the importance of diving deeper, exploring the unfamiliar, and the power of sharing to learn from a diverse range of voices a true cornerstone of growth.















ACEL INCLUSION & DISABILITY CONFERENCE 2024 **LEADING AN INCLUSIVE** CULTURE THROUGH Engagement AND **DARWIN, MAY 30 - 31** 

The ACEL Inclusion and Disability Conference: Leading an Inclusive Culture through Engagement and Wellbeing was proudly presented in collaboration with the Northern Territory Department of Education in Darwin from 30-31 May, 2024.

Inspired by the Alice Springs Mparntwe Education Declaration's goal of "providing all young Australians" with access to high-quality education that is inclusive and free from any discrimination", the two-day conference was attended by over 300 delegates from across the nation and internationally.

The conference theme provided the perfect opportunity for educators, researchers, policy makers and leading practitioners to share insights, listen to lived experiences, network and learn ways in which we can all make practical changes within our school and community ensuring every young person enters and leaves school with a sense of belonging. A strong feeling of connection and collegiality was woven through the conference, as shared in one reflection from a graduate teacher:

### **Programs**

#### **Leadership for Middle Leaders Online Program**

is designed for teachers and middle leaders who are ready to take the next stretch in their leadership and provides a closer exploration of the knowledge, skills, and confidence to lead and develop others for effective leadership for school communities. Over 250 participants have completed the program with requests for bespoke programs continuing to build through the ACELearn platform.

#### Women in Leadership

A program for aspiring and experienced leaders is currently being co-constructed and delivered in collaboration with a number of networks and sectors, including most recently the Association of Independent Schools South Australia (AISSA). The program involves workshops, masterclasses, webinars, assessment and reflections tools, and professional companioning and mentoring. Its emphasis is on engaging with, and being energised by, like-minded colleagues, and includes the completion of a personalised action plan to inform and build a personal philosophy and professional identity.

#### **Curiosity & Powerful Learning**

With the program delivered online over the past few years, this was an opportunity for participants to meet each other in person, share their experiences, as well as to hear from Professor Hopkins live. We held the final conference for the latest cohort and a masterclass for those who participated in earlier cohorts over three days in November 2023.

#### **Growth Coaching International**

This year ACEL was delighted to partner with Growth Coaching International to bring the *Coaching in Leadership* course to educators across Australia. This course is practical and evidence-based that provides in-depth learning and experience of the application of coaching approaches as a highly effective way of leading in schools and other education settings.

#### **ACEL Coaching and mentoring**

ACEL continues to offer short mentoring/coaching packages ranging from three to ten hours to meet each participant's learning goals. ACEL's mentors/coaches are an experienced group of professionals covering a diverse range of expertise. The program provides a great opportunity for experienced educators to give back to the profession by sharing their skills/knowledge, but also great for the participants to receive a personalised one-on-one session suited to their needs.








# ACEL Bookshop and Resources

# Journals and Publications

ACEL's Journals and publications are a key component of its mission to ensure educational leaders have access to high quality resources on relevant topics such as current research, policy developments, and best practice. The opportunity to present the voices of established and emerging leaders as well as researchers and practitioners is a source of great pride for the organisation and for ACEL's publications. Moreover, offering a lens into different contexts and practices told by teachers and leaders in schools and other education-related organisations, is a key pillar of ACEL's strategic focus.

ACEL disseminates, promotes, and publishes research via its four key publications (Leading & Managing, the ACEL Monograph, New Voice Perspectives and the Australian Educational Leader).

Leading & Managing (L&M) is a well-recognised blind peer reviewed journal, published twice a year that furthers academic discourse around educational leadership. Its focus is education management and leadership in the widest sense and within contexts such as schools, higher education institutions, and other educational organisations. In 2024, ACEL entered a new phase in its development with a reconstituted editorial board comprising national and international board members, a new editorial partnership representing Australia and the United States, and the implementation of an OJS (open journal system). Editors Professor Fenwick English, Associate Dean of the College of Education at Florida Gulf Coast University and Professor Dorothy Andrews, University of Southern Queensland have indicated their intention of pursuing the challenge of indexing so that L&M can become a journal with an academic ranking. L&M became an open access journal which means it is available free of charge to anyone who wishes to access it.

Each year, the Australian Council for Educational Leaders is proud to present **New Voice Perspectives**, celebrating our New Voice Scholars who have been recognised in the fields of school leadership, educational leadership research, and early childhood and care. The 2023 New Voice Scholars were asked to respond to one of four questions considering how leaders inspire hope and create the future; the three main global challenges facing educational leaders; what it means to be an educational leader in 2023 and how in the age of Al how leaders can retain a human focus.

In 2023 ACEL celebrated 50 years of leadership and dedicated service. To mark this auspicious occasion ACEL Patron, Frank Crowther, with a special contribution by Brian Caldwell, was commissioned to write a **commemorative monograph** that told the inspirational story of the Australian Council for Educational Leaders. The monograph was launched at ACEL's national conference held in Sydney, 2023.









# Journals and Publications

**Australian Educational Leader (AEL)** is widely considered the premier practitioner-focused publication in current circulation for educational leaders across the country. Both experts and practitioners contribute regularly to AEL.


AEL is managed by Project Manager/Editor Dr Lisa C. Ehrich who works closely with 12 experienced educators/ educational leaders who form the editorial board producing four quality issues of the journal each year. The Project Manager in concert with the Chair (Dr Kirk Zwangobani) and board members solicit articles (i.e., lead, general, and success stories) from academics and practitioners alike, review these articles, and then make a determination as to their suitability for publication. AEL is an in-house publication that is produced in two modes: online and in print by ACEL's publication team.

Australian Educational Leader

An important collaborative decision that is made yearly by the Project Manager, Chair, and board members is identifying themes for each of the four issues. During the last financial year, these themes varied in both nature and focus and included "leading, learning, and shaping the future together" (issue 3, 2023); "data to improve learning, (issue 4, 2023); "reimagining schools" (issue 1, 2024), and "leading effective teams (issue 2, 2024). All four issues attracted a range of interesting, innovative, and inspiring articles drawn from Australian and overseas experts who showcased their research. Among these leading experts were Professor Andy Hargreaves and Cameron Jones; Professor Pasi Sahlberg; Dr Lyn Sharratt; and Professor Emeritus Brian J. Caldwell. A highlight in all issues of the Australian Educational Leader is a section that celebrates good practice, success and innovation. Some of the success stories covered important and interesting topics such as leading a critical transformation approach to school improvement; creating a data-informed culture in the Northern Territory; reimagining the future at Gowrie Victoria Broadmeadows Valley; and prioritising staff so they can prioritise children in an early childhood setting.








## **Membership**

Within the Members' Lounge is the **ACEL Leaders' Library**, an extensive user friendly collection of resources at the fingertips of ACEL members.

As of today the library contains thousands of articles and resources, including over 6 years of full keynote videos and webinar series. The library is now the digital home of ACEL's flagship journal the Australian Educational Leader (AEL).

We continue to strive to make the Members' Lounge a growing benefit to the industry and a seamless way to connect via blog posts, news announcements and a detailed calendar.

This year has seen some major change in the NSW Branch. Nearly half of the Branch Executive changed, with longstanding members retiring due to the expiration of their term: Dr Tony Bracken, Joanne Jarvis, Dr Michael Krawec, Dr Andrea Stringer, and our President, Associate Professor Kylie Lipscombe. Kylie served with distinction across the period 2020-2023, a period overshadowed in so many ways by the impact of COVID on leaders and the wider collegial and professional learning landscape. We owe her much thanks and wish her well as she continues to lead with distinction in her academic field of middle leadership.

The Branch Executive welcomed back some experienced and new members, spending time setting down key priorities for our three-year term. Two overarching priorities emerged from our discussions: the need to engage more colleagues in the government sector, and a need to rethink the difference between professional learning needs and collegial connection as we plan annual calendars. With an increased representation from the government sector, our strategies focus on facilitating growth in both membership and involvement in professional learning opportunities within the sector.

Consistent with wider national conversations, we are developing strategies to engage in collegial conversation as a complement to professional learning offerings. Inspired by approaches across other branches, we are exploring a range of no- or low-cost socially orientated opportunities to bring us together more frequently. This year has been a year of thinking and planning; next year we set out on this new adventure.

A major milestone has been the consolidation of the New England Awards into the NSW Branch Awards. The connection of ACEL to the New England region goes back to the earliest days of the association, with many of the driving forces in establishing and building ACEL connected with the University of New England. Over time, as these relationships changed and ACEL's national footprint grew, the New England Awards continued to acknowledge outstanding leaders in the area. Recently the National Board conducted a major awards review determining a more consistent approach in the years ahead to the NSW awards process through the oversight of the NSW Branch Executive. It was wonderful therefore to have a Team Leadership Award presented to the University of New England's Commencing Student Success Project and an Individual Leadership Award presented to Associate Professor Ingrid Harrington.

Bringing the history of these awards into the wider NSW Branch Awards has been an important, yet time-consuming process, and I wish to record thanks to National President Dr Briony Scott and CEO Dr Barbara Watterston for their commitment, as well as Peter Pickett, Chair of the New England Awards, who has administered these awards generously and faithfully for many years.

Along with these changes, our awards this year were a showcase of what makes ACEL such a unique community. Award recipients came from all three school sectors – government, Catholic, and independent – and from nearly all education tiers – primary, secondary, tertiary, and education system leadership contexts (we missed out on nominations from the early childhood community). To top it off, it was a joy to present the Patrick Duignan Award for Leadership to Kylie Lipscombe, and the Dr Paul Brock Memorial Medal (our most prestigious award) to Joanne Jarvis, both former Branch Executive members. Special thanks are due to ACEL staff who make this event such a success – Peggy, Sharissa, and especially the indefatigable Elaine!

In November 2023, we hosted a highly successful middle leadership learning showcase at the Strathfield Campus of the Australian Catholic University. The event was oversubscribed, with strong engagement and case studies from each sector aligned with our strategy. Animated by our vision, the NSW Branch Executive is energized and optimistic, as we build on the strength of our history and richness of tradition.

## **NT Branch Report**

Presenters from the following organisations shared their innovation journeys this year: All Saints College; Association of Independent Schools of WA; Bob Hawke College; Challis Community Primary School; Clarkson Community High School; Corpus Christi College; Dayton Primary School; Harrisdale Primary School; Irene McCormack Catholic College; Perth College; Piara Waters Senior High School; Scotch College; Servite College; St Mary's Catholic Primary School Donnybrook; The Studio School; and Willetton Primary School.

We continued with our termly holiday Educational Leadership Book Club, which creates opportunities for leaders to engage with a diverse range of leadership theories, strategies, and perspectives that they might not encounter in their daily work, and discuss them with likeminded colleagues from different educational leadership contexts. Books discussed this year include "Virtuous Educational Leadership: Doing the Right Work the Right Way" by Viviane Robinson; "The Song of Significance: A New Manifesto for Teams" by Seth Godin and "The Leading Edge: Dream big, spark change and become the leader the world needs you to be" by Holly Ransom; and "Atomic Habits: An Easy & Proven Way to Build Good Habits & Break Bad Ones" by James Clear.

The WA branch hosted a Hot Topic on the Challenges and Opportunities of Leading in Regional Contexts with four leaders sharing their experiences: Brad Evans (Principal at Georgina Molloy Anglican School), Franca Dillon (Principal at Bunbury Primary School), Keith Nicholas (Principal at John Paul College in Kalgoorlie) and Vince Bellini (Principal at Our Lady of Mercy College in Australind). The branch also hosted an innovative workshop with James Nottingham from the UK on The Learning Pit: Improving Students' Attitudes Towards Challenge, where James led a workshop in the morning, followed by him leading two demonstration lessons, one in a primary classroom and one in a secondary classroom in the afternoon, demonstrating how to put the techniques discussed in the workshop into practice by guiding students (that he had never met!) through the Learning Pit methodology.

Our Branch Awards Night in November was another highlight where the WA Minister for Education and Training presented awards to 19 inspiring, emergent, and established leaders across the state, culminating in recognising Jacqueline McGowan-Jones, Commissioner for Children and Young People in WA, as the ACEL WA Pre-eminent Educational Leader for 2023. The WA Branch also partnered with National Office to host a workshop by Dr Selena Fisk on Leading Data-Informed Change, where Selena shared some of her non-negotiables around data, including the importance of being student-centred and data informed, not data driven.

I want to thank the WA Executive Branch members for their hard work and dedication throughout the year to serve the wider educational leadership community in WA: Vince Bellini, Dr Ray Boyd, Carol Daniels, Tamara Doig, Dr Daniel Groenewald, Eleanor Hughes, Rachael Lehr, Krystal McKnight, Kathryn Netherwood, Gary Racey, and Maree Whiteley.

Finally, as I prepare to move to Victoria in 2025, I want to thank the ACEL WA membership for the opportunity to serve on the executive since 2018 and as Branch President since 2022. I still remember when I attended my first ACEL event. I couldn't believe there were so many people "speaking my language", equally passionate about student learning, teacher learning and building significant, purpose-driven school cultures. I felt I had found my tribe. I love the egalitarian nature of ACEL where hierarchies and differences disappear in a joint celebration of the sophistication, hope and significance of the teaching profession. I will miss the WA branch but look forward to reconnecting at national events.
