### From the President





It is with great pleasure that I provide this report on behalf of the ACEL Board of Management. In the past twelve months, we have built on the strong foundation that we laid last year and I am pleased to report that our organisation is now in a strong position financially while continuing to enhance our position as the premier professional association in the education sector across the Asia-Pacific region.

I feel very proud of the ACEL Board, staff, members and particularly our CEO for their collaborative efforts over the past few difficult years. In an extremely tight and resource constrained environment and at a time when our members are rightly questioning the value they get from their membership, the past financial year ACEL has arguably had one of its most successful years since our inception. Not only did we make a net profit of over \$450,000 dollars but we also relocated our national office to Sydney, had stability and collaboration in relation to national Board membership and we set about designing a relevant and guaranteed future for the organisation. We now have retained earnings of around \$700,000 which provides us with breathing space and places us in a positive position to plan more thoroughly for further growth. The financial turnaround for ACEL, in some ways, is analogous to small rural school with the lowest ICSEA topping the NAPLAN results for the nation!

As we know however, amazing school turnarounds do not always endure if

those elements that drove the change are not sustained. Collaborative leadership, well developed staff, stakeholder commitment and high quality service delivery that is underpinned by rigorous accountability must be in place to ensure that gains are not lost or squandered. So it is with ACEL. During this break in clouds, and while the sun is shining, we must collectively decide what we want from this unique organisation and then put the foundations in place to ensure that we best serve the education profession but don't lose sight again of what is required to keep us buoyant and thriving. As Charles Darwin pointed out, the secret to survival is not about being the strongest, it is about being able to adapt within a changing landscape. I therefore, write to challenge our membership at this pivotal time because I was part of a similar experience about a decade ago where I was the chair of a not-for-profit organisation that managed to galvanise its members, board and the general public at large to contribute to a similar rapid and quite amazing turnaround. Despite the rescue and apparent sustainability, the same organisation in 2013 now finds itself again beset with a large deficit and an uncertain future. It is a very sad story that primarily came about because the corporate memory and governance structures were not 'built to last' so as to enable new staff and board members to understand past mistakes and to mitigate future risks in order to insulate the organisation from self-harm.

As we all know it is hard, if not impossible, to guarantee the future of any organisation as times change due to the economic climate, rapid internationalisation, shifting consumer demands, the impact of technology and a range of other factors. To set ACEL up for sustainability, we need to decide what we want the organisation to provide and what it stands for. We need to enshrine the values that underpin the organisation and we need to professionalise the business side of the operation to ensure that risk is well managed and resources are wisely invested to enable us to focus on improving lives for students. To that end, we have developed a 3 Year ACEL Strategic Plan which will, hopefully, provide consolidation for us as we move into a better business model to

support our work. We need however, to continually improve our governance and we will therefore be refining the composition of the board to ensure that in addition to the Branch Appointed Directors that represent the membership across all states, we also appoint Independent Directors with relevant skills such as legal, financial, governance, business, project management, human resource or a myriad of other specific competencies that will be important for the independence and growth of ACEL as we move forward.

Finally, I acknowledge the achievements of all of our highly esteemed award winners for 2012 and again, acknowledge the Board of Management, our Patron Frank Crowther and the many other committed volunteers for their willingness to proactively invest their precious time into such a worthy cause. I would also like to acknowledge our former President Neville Highett whose term of office has now been completed, for his outstanding stewardship and loyalty to the organisation during his years on the Board. Neville's dedication and commitment will be missed but his legacy will ensure that we continue to build on our success to future proof ACEL so as to serve the education profession during these turbulent times. Congratulations Neville on a job well done.

### From the CEO



ACEL's phoenix-like resurgence over the past two years has underscored important lessons in adaptiveness. At its core it has meant re-visioning the new and evolving needs and expectations of our six thousand five hundred members, and rededicating the organisation to fulfilling its purpose of inspiring and supporting them through their zeitgeist challenges.

This intent has highlighted the imperatives for strategic capability development in both our governance and operational management. Our work thus far mirrors the dialectic tensions of all fecund and flourishing endeavours - daunting and exciting, difficult and energising, and most importantly, all-consuming and very rewarding. The quantum leap in every metric of ACEL's performance is testimony to the efficacy of our organisational renewal program and augurs well for its enduring future.

The past twelve months have been very profitable for ACEL. It has resulted in a significant surplus of nearly four hundred sixty thousand dollars for the financial year ending June 30th 2013. Retained earnings have increased as a consequence and our liquidity position has also improved considerably. Underwriting financial security is a constant work-in-progress. Our goal is to be self-sufficient in the immediate term and self-sustaining over the longterm, in order that we may continue to serve both our members and the wider education community well into the future.

Our branches in the states and territories have played a vital role in driving both visibility and reach for the organization. We have attracted new members even as renewals have stayed steady. A new membership category introduced for teacher leaders has proved popular. ACEL has also instituted Lifetime Memberships to recognise our long-standing retired ACEL Fellows. Networking and Professional Development events for our target audiences have registered a manifold increase over the past year. This has resulted in flow-through effects for attendance at our awards functions both at State level and at the President's Awards Reception held during the National Conference.

We have arguably become the premier provider of a variety of contemporary and needs-focused resources for educational leaders. These include amongst others:

- A fully revamped Australian
   Educational Leader Journal (AEL)
   with a modern look and feel and
   much wider accessibility online,
   digital and print;
- 2. A new Executive Leadership Program developed to address the complex needs of high-performing educational leaders;
- 3. The 21st Century Fluency Workshops Tour designed to support educators in the implementation of the National Curriculum;
- 4. The October 2012 conference, "An Inquiry Mindset," that used a three-tier structure of, "provocation, purpose and practice" to make for a compelling learning experience.

ACEL owes a huge debt of gratitude to many people for the significant turn-around in its fortunes – our Branch Executives for their passion and commitment; our Lifetime Members and Fellows for their generosity in sharing their wisdom and experience; our dedicated staff at the National Office in Sydney CBD for their professionalism and hard work; our supportive Board Members who steward the organisation so conscientiously; and finally our Members, whose unwavering support

and patronage has enabled ACEL to weather the recent challenges and grow.

In his magnum opus, Outline of History, H. G. Wells famously remarked, "human history becomes more and more a race between education and catastrophe" (Wells, 1920, p. 1100). His words echo presciently as we in the education sector in Australia look to the future. Each one of us in ACEL however, can take great heart from our knowledge that in our raison d'etre of inspiring, supporting and recognising excellence in educational leadership across all sectors we are acting purposefully to win this race because in the end, " learning is the major process of human adaptation" (Kolb, 1993, p. 149).

ACEL Membership has steadily grown over the past year with new members continuing to join as well as regular membership renewal from our existing members. Over the past year 667 new members have joined ACEL.

#### **Teacher Leader Membership**

We launched the new Teacher Leader membership category in May 2013, which has so far generated 36 new ACEL members. This membership specifically caters to teachers who want to develop their leadership skills and engage in dialogue with regard to the future of education in Australia. Teacher Leaders receive unique membership benefits including a special invitation to an exclusive open forum with global thought leaders prior to the ACEL National Conference which will be held this year on the 1st October in Canberra; an invitation to attend a branch networking event for Teacher Leader members: and complimentary attendance to an ACEL professional learning event, either faceto-face or a webinar. The Teacher Leader membership category replaces the old Teacher category, and existing Teacher members were given a complimentary membership upgrade, which has received a very positive response.

#### Lifetime Members

In June 2013, we awarded Retired Fellows of ACEL who have been members for 20 years or longer, a Lifetime Membership in recognition of their support of ACEL and their achievements. This was awarded to 25 recipients. The feedback from this initiative has been overwhelmingly positive

### ACEL Events

It has been a strong year for ACEL events – our National Conference, nationally driven PD events and our branch-level events have been positively received, been well-attended and have bolstered ACEL's bottom-line.

The first round of 21st Century Fluency Workshops, conducted by Lee Crockett, were a resounding success both in attendee satisfaction and profitability for ACEL.

A number of other workshops took place in this period, including forums lead by Peter Adams from ACARA, Principal Effectiveness workshops led by Professor James Stronge and Coaching workshops led by trainers from Growth Coaching International.

The first workshops in partnership with UTS were held during the year, which has now developed into a suite of events based in Sydney on a range of topics important to educators and school leaders.

## ACEL 2012 National Conference: An Inquiry Mindset

The ACEL 2012 National Conference was a huge success in a number of areas, particularly in terms of delegate numbers, positive attendee feedback and its financial profitability. The event was attended by over 900 delegates representing all sectors in the Australian education community, with others attending from the UK, USA, Sweden, Saudi Arabia and a number of other countries.

Key Speakers included Daniel Pink, Reverend Tim Costello, Lee Crockett, Professor Theo van Leeuwen and Tony Mackay. Underpinning the overarching theme of 'An Inquiry Mindset' were the following 5 sub-themes:

- Creating personal capacity
- Building inspirational learning teams
- Fearless leadership
- Seeding ideas, nurturing innovation
- Growing a culture of creativity



- In 2013 AEL had a complete redesign, freshening up the cover and content format, to reflect the changing times of publishing. We also launched AEL digitally with a brand new journal dedicated website.
- AEL members can now log in using their ACEL membership details and view all AEL content and back issues.
   Non-members can view selected content from each issue. Already members have responded well to this and ACEL has now introduced a comments section with each online article to encourage reader interaction.
- ACEL has also established an Editorial Advisory Panel to review all its educational content.

 The Perspectives publications offer a valuable insight into education today, edited by Professor Neil Cranston of the University of Tasmania. Over the past 12 months ACEL has produced six Perspectives journals in electronic format

#### Leading & Managing (L&M)


- L&M is available in print and online to all ACEL members twice a year in Autumn/Winter and Spring/Summer.
- It continues to be edited by an editorial team at the University of Southern Queensland, with the first 2013 issue sent to members on the 12 June.
- In 2013 ACEL have refreshed the design of the cover to reflect the changing times in education and publishing and will now use Complete Printers to print the journal.

#### **Books & ePublications**

- Over the past 12 months the titles available to purchase through ACEL's online bookshop (for both members and non-members) has expanded dramatically.
- ACEL offers subscriptions for three e-publications – e-teaching, e-leading and e-shortcuts. We currently have around 400 e-Publication subscribers, who receive content by email weekly and monthly.







### ACEL Academy

ACEL continues to work with a number of schools, network groups and departments across the country, supporting educational leaders with a diverse range of learning options to enhance their leadership capabilities.

The Executive Leadership Program launched earlier this year, has been designed specifically for leaders looking to expand their influence and deliver outstanding outcomes. The content has been developed from multiple disciplines and domains to ensure that the most current concepts and research both within and outside education are integrated into the learning experience. The program contains a fully integrated and responsive framework and can be tailored to suit a variety of cohorts and contexts.



We have introduced a number of faceto-face modules to support the online learning from the ACEL Leadership Capability Framework. We also continue to expand the reach of the Diagnostic Inventory of School Alignment (DISA) in partnership with the University of Southern Queensland.

ACEL has been engaged in delivering a professional development program to the leadership team and also conduct a strategic review for Catholic Education Northern Territory.

- 2. Assistant Principals Network
- 3. Teacher Leaders
- 4. Katherine Region Network
- A professional learning coalition made up of key organisations such as the NT Centre for School Leadership learning

- and Development (CSLLD), Australian and Northern Territory School Education Leaders (ANTSEL) and ACEL NT was developed. This coalition developed a 12 month professional learning plan to provide current and aspiring leaders in the NT with a range of professional development opportunities.
