

This year we have continued to deliver on ACEL's purpose as a charitable institution established to support, develop and strengthen educational leadership capabilities across Australia and internationally. Throughout this year's Annual Report the key activities and achievements of the organisation are presented to our members and represent the work of our National office and our volunteer State and Territory Branch presidents and executives.

ACEL has continued a significant period of stability and year on year growth both in membership and finances. Thanks to the work of the ACEL team, the organisation's sustainability is well established with solid foundations of diversified revenue streams, our own office and delivering quality services to our members and the broader education profession. ACEL continues to be highly regarded in the provision of resonant, authoritative and innovative professional learning opportunities, resources and materials as well as sharing distinctive, forward-thinking, relevant, responsive and world-class services.

The stability of the foundations of the organisation has allowed the ACEL Board to turn our attention to the broader remit of our organisation and strengthen our impact on shaping the practice and contributing to the growth of educational leadership more broadly. Our most recent edition of Australian Educational Leader, includes contributions from leading educational researchers such as Professor Emeritus, Brian Caldwell and Dr Lyn Sharratt, two PhD candidates, those on the ground working in our schools such as Rebecca Well, Assistant Principal, Camberwell Primary School and Cameron Paterson, Head of Teaching and Learning, Shore School, a classroom teacher and not to mention the Secretary of the Victorian Department of Education and Training. This is one of the ways ACEL provides a platform for educational leaders and individuals who have an interest in the profession to share discourse and research.

We continue to be proud of the contribution ACEL is making to the education leaders of tomorrow through our New Voice Scholarships. This ten year \$300,000 commitment to supporting the growth of the profession continued in 2018 with the forth intake providing a further twenty scholarships to future educational leaders. This is a demonstration of the strength of our member based organisation to support building leadership knowledge, skills, understanding and capability of current and future leaders. Our New Voice Scholar's participation at our National Conference is always a highlight and their contribution to our publications is always well received.

Of course none of any of this happens without the significant work of our CEO, Aasha Murthy, our National team and State and Territory Branch presidents and executives. This Annual Report represents the first full year of the leadership of a number of new State and Territory Branch presidents. Through the volunteer work of these individuals and their executive teams membership in all States and Territories has increased again in 2018/19. This year has also seen a further strengthening in the collaboration of the Branch presidents working closely with Aasha and the team to deliver a vast array of services across Australia. Increasingly, this has included providing our professional learning and program opportunities in regional Australia. This is delivering on a key priority of our current Strategic Plan, extending the reach of ACEL to members and customers in regional and remote areas of Australia.

ACEL continues to go from strength to strength and this year has been no exception. I am proud of the work of our organisation and present to you, our members, our 2018/19 Annual Report. I look forward to seeing you at our 2019 National Conference and Annual General Meeting.



## //CEO's Message

The above quote is as true of institutions as it is of people - resetting goals, refining expectations and updating practices is vital in order to avoid hubris and complacency. Learning is the best form of adaptation and helps individuals and organisations to keep pace with changes in the environment and stay relevant and contemporary.

Over the past few years, ACEL has established itself as the only national, cross sectoral independent entity that serves the education profession. Our carefully constructed offering strikes a resonant chord with our members and customers' needs. As in previous years, ACEL's financial performance has been robust, with a net surplus of \$146,881.98 in the financial year 2018-19. This has increased retained earnings to \$2,508,209.42 as on the 30th of June 2019. Our total assets of 3.8 million dollars which include the office premises and a healthy cash balance, underpin our financial independence and enhance our ability to serve our stakeholders better.

As ACEL comes of age and gains stature in the sector, it is keenly aware that its maturity is an earned status that carries responsibilities with it. Ergo, our organisational purpose, is enshrined in the five pillars of our Strategic Plan -Professional Learning, Dynamic Networks, Recognition of Excellence, Enlightened Discourse and Exemplar Organisation.

Our performance in 2018-19 against these pillars is detailed below:

#### **Professional Learning**

We have established an extensive portfolio which includes conferences and seminars & workshops. We hosted 3 conferences every year - the Disability Summit which focuses on leading learning for students who have special needs; the Early Childhood conference which draws attention to the importance of the early years; our flagship national conference that sets the learning agenda for educational leadership. We hosted over 150 seminars and workshops around the country on relevant topics featuring leading experts like Andy Hargreaves, John Hattie, Lyn Sharratt and Doug Fisher among others. We have expanded our portfolio of programs targeting both individual leadership and school improvement. The most significant development in the past 12-18 months is the significant expansion of our digital and online resources available free for members or on demand for educators who are time poor and/or located in regional/rural/ remote settings. These resources include webinars, podcasts, interviews, articles et al with contributions from global experts.

#### **Dynamic Networks**

Our membership continues to grow which is really pleasing given the industry trends for membership-based organisations. Particularly gratifying is the growth in regional memberships and the marked increase in institutional sign ups. Our customer base has increased significantly with over 100000 educators now part of our network connecting with us in a variety of ways - attending programs and events, buying books, subscribing to publications and accessing online content. Our existing partnerships with peak bodies and likeminded organisations have strengthened even as we forge new relationships with global and local entities. Our branches have established strong relationships in place with the different sectors of education in every state and territory.

#### Recognition of Excellence

Educators are particularly modest about the contributions that they make in their classrooms, schools and systems. It is therefore appropriate that we acknowledge their work through our fellowships and awards. We continue to do this at the state/ territory and national levels by recognising excellence in individuals and groups, who are nominated by their peers. The New Voice Scholarships initiative is now in its 5th year - the Class of 2019 are another group of talented and enthusiastic professionals, who are on their way to becoming future leaders in their settings. Since the program's inception, we have awarded over 80 New Voice Scholarships across four categories - Educational Leadership, Educational Research, Indigenous Leadership and Early Education and Care.

#### **Enlightened Discourse**

Our journals and publications provide the ideal platform to showcase the most current research, policy and practice in the education sector globally and from around Australia. The Australian Educational Leader (AEL) journal is considered the best of its kind in the world. The new features introduced last year - the success stories, spotlight interviews and the In-Context section - have resonated with readers and complement the lead articles written by leading experts. We produced two Monographs in the past year and are currently working on repositioning the Leading and Managing (L&M) journal to make it even more attractive to researchers and academics. Our branches have hosted over 30 forums providing an opportunity for educators to engage in lively discussion and debate on topics of interest. A significant initiative launched in June was the formation of an Advisory Group of Australian Academics who will work with us to create meaningful links between Australian research to educational leadership.

#### **Exemplar Organisation**

In the past year, we have further strengthened our Governance structure with committees in place to support various aspects including Audit & Risk, Professional Learning, Awards & Scholarships and Remuneration. Keeping pace with the growth and increasing complexity of our portfolio of programs, events and resources, we have brought in greater expertise into the management team at the national office. We have also established a skilled group of program facilitators, writers and mentors that assist us in delivering on our goals and objectives.

As we reflect on the past 12 months, it is clear that our achievements and success has been delivered by a strong team effort! Our team at the National Office, our Branch Executives, our Lifetime Members, Fellows, our President and Board, our Membership and the larger educational community have all played their part in making 2018-19 another special year in the history of ACEL.

I look forward to meeting many of you in Sydney during the ACEL National Conference, from the 2<sup>nd</sup> to the 4<sup>th</sup> of October. It promises to be a very special learning experience, and I know you are as keen as I am to be part of the event!



#### //Conferences

The National Leadership Conference, the flagship event in our calendar, held at the Melbourne Convention & Exhibition Centre, Sydney's new Convention Centre attracted around 900 educators from around the country and wider region.

A large percentage of attendees were non-members which shows not only the interest in the topic itself but helps to further ACEL's goals of enhancing its reputation within the broader Australian education sector and in particular the emerging area of discourse around early childhood education.



This year saw significant growth in the numbers of participants for our seminars and workshops. We hosted both Australian and international speakers across the country.

Through our partnership with Corwin, we were able to continue to reach into and beyond the capital cities. Professor John Hattie's Visible Learning Symposia continued to attract significant participation across Australia.

#### //Resources In Action



Resources in Action continued enhancing our online portfolio of content. ## //Programs

Curiosity and Powerful Learning has continued to gain traction with its further expansion in NSW as well as regular interest from other states. The program, based on original research by Professor David Hopkins, operationalised by ACEL in partnership with McRel, has been customised to suit the needs of the NSW Public School system. In addition to the main program we have hosted conferences for Curiosity and Powerful Learning participants and David hosted a successful followup program for Directors, Educational Leadership in May 2019. The program maintains strong feedback citing a tangible impact on teaching practice and student outcomes. We expect the program to continue expanding, following up with both school leaders and Directors, Educational Leadership.

The signature Executive Leadership Program was delivered to leadership teams in a variety of contexts – large schools based in major centres to networks of leaders in regional settings. The program has enduring appeal and is constantly sought after by leaders keen to update their skills in an ever-changing world.

The "Leading School Transformation" and "Building Your Leadership Capacity" programs were well received. The target audience for this suite of programs ranged from classroom teachers through to system leaders.

#### //ACEL Bookshop














It was a record year for the ACEL Bookshop almost doubling the revenue and titles stocked and sold. The online bookshop remained a trusted source for educators, libraries and institutions to purchase books and resources to cater for individual professional development as well as bulk orders for their schools and libraries. We maintained this consumer confidence by curating an extended range of authors and titles specially targeted to educational leaders across all contexts and levels. Exclusive ACEL editions and box sets plus exclusive ACEL release windows on major education titles further established our position as the leading book retailer within the education sector in Australia. Over the last year ACEL co-published our number one seller of the year "Clarity" by Lyn Sharratt, and launched exclusive editions from John Hattie, Dr Todd Whitaker and Dr Barbara Blackburn among others.

The ACEL Bookshop also evolved to be fully integrated into events and conferences with the extension of book bundles and upgrades to workshops, and the presence of renowned Australian authors at major events where audiences have the opportunity to engage via book signings, meet and greets and live interviews.

## //Digital & Online Content

In the last year ACEL launched a new digital and online content strategy that will continue to evolve and be an important key resource stream for our members and customers. Over the last year we increased the focus of three digital content streams – ACEL Resource Centre [online articles and resources], ACEL Leader's Library [Video content, interviews and podcasts], and ACEL Webinars [regular online workshops featuring leading local and international educators]. Content across the streams included such thought leaders as John Hattie, Barbara Blackburn, Todd Whitaker, Lyn Sharratt and Bryan Goodwin.

These three streams each saw growth in both content and users over the last year with ACEL establishing an umbrella brand portfolio to house all three with the newly established ACEL Leader's Library. Providing 24/7 access to leading resources and content the Leader's Library is also an important part of our strategy to ensure accessibility of resources for our regional and international members and customers.

## //A Growth Story...

In the past year, Membership has continued to build across all states and territories. Institutional memberships have shown further growth, with a greater number of schools bringing their key teachers and leaders into the fold.



## //ACEL Membership

Over the last year ACEL membership continued to build across all states and territories in Australia as well as New Zealand and other countries. We finished the Financial Year 2018-19 with the highest number of members to date in the organisation's history, recording growth in every month against the previous financial year. For the second straight year, we made significant gains in Institutional memberships with new schools signing up and existing ones adding more staff to their roster. There has been a significant uptake of multi-year memberships [2, 3- & 5-Year membership options] which demonstrates educators' confidence and commitment to ACEL.

New Membership benefits were introduced including increased digital content, webinars, and online resources which were tailored to meet the needs of schools in regional/rural/remote locations who have limited access to professional development events and programs. This had a desired impact on growth in regional membership, now set up as a dedicated category at a subsidised rate to encourage greater participation.

#### //Partnerships

Partnerships and collaboration between ACEL and the leading names in education continued to flourish over the last year. Building on both established partnerships while simultaneously introducing new relationships our partnerships saw ACEL work together with like-minded organisations to deliver co-operative events, publications, workshops and promotions. ACEL's ongoing partnership with Corwin saw us deliver Visible Learning workshops across Australia. Our partnership with McRel international continued to grow through our successful Curiosity and Powerful Learning Program.

ACEL partnered with the two major education systems the Department of Education NSW being our presenting partner on our Early Childhood Conference and the Department of Education & Training Victoria, our principal partner in National Conference 2018. ACEL's association with peak bodies like AITSL and partners and ACECQA.





ACEL has built strong relationships with leading publishers and media partners in the delivery of core events and promotions. Active participation from publishing houses across Australia including Pan MacMillan, HarperCollins, Taylor & Francis and ABC Books has included provision of speakers and authors as well as publicity around our largest summits and conferences. Media outlets such as ABC provided a communications and awareness platform for ACEL in a strategic and ongoing media partnership program.














#### //Online and Social Media \_\_\_\_\_

The ACEL website has had a major revamp through 2018-19. Content and visual upgrades were implemented to ensure that the site is 100% mobile compatible and presents an integrated brand and look & feel across all key areas within the portfolio. Finally, several features were introduced and/or modified to improve on the customer experience and functionality of ACEL online.

Integrated communications across direct, social media and external messaging saw both record rates in website page views, click rates and time spent on the ACEL website. This approach has resulted in double digit growth in average customer spend per head as products and messaging became more accessible, clearly identified and the ease of the customer journey through the site.

Social media remained a focus over the last year to communicate core messaging and organisational announcements. Social media followers increased 34% over the last year with all three main mediums [Facebook, Twitter and LinkedIn] delivering significant growth across all three platforms. ACEL social engagement for the second straight year delivered triple digit growth led by a strong engagement across Twitter and Facebook over five times the education industry average increasing by 115% over the previous year.

ACEL NSW is deeply aware of the influence of educational leaders in enabling our children and young people to succeed. We know that what leaders know and care about permeates their expectations, actions and outcomes. It is for this reason that we place a clear emphasis on professional learning, research, publication and advocacy. ACEL plays a key role in education and leadership in NSW. This role is recognised through high engagement in professional learning and strong membership. ACEL NSW represents one third of the national membership and is continuing the build upon this foundation.

#### Professional Learning

ACEL professional learning continues to be widely acclaimed with over 2500 educators attending and strongly evaluating ACEL professional learning held in NSW over the last year. NSW ACEL continues to support educators in both metropolitan and regional NSW with major programs running in nine regional centres as well as Sydney. The regional seminars are very popular with registrations larger than those in most of Australia's capital cities. This strategy continues to be financially viable as well as morally responsible.

Over the last year high quality professional leaning has been provided by both international and local educators. International program presenters have included Prof. Alma Harris and Dr Michelle Jones (UK), Doug Fisher (USA), Prof. Andy Hargreaves (USA), Russell Quaglia (USA), Lyn Sharrat (USA) Bryan Goodwin (USA), Robert Biswas-Diener (USA) and Barbara Blackburn (USA). The Visible Learning programs presented by Prof. John Hattie and the Curiosity and Powerful Learning programs presented by Prof. David Hopkins (UK) continue to be highly evaluated.

The provision of local seminars and the expansion of webinars has enabled increased access to quality professional learning for rural and remote educators as well as school leadership teams. As an endorsed provider of professional learning with the NSW Educational Standards Authority, ACEL provides professional learning aligned to the Australian Professional Standards for Teachers at Lead Teacher

The collaborative partnership between ACEL and the NSW Department of Education continues to enable the provision of world class educational conferences. The highly successful National Disability Summit and the Early Childhood Conferences were held in Sydney in partnership with the NSW Department of Education. The NSW Department of Education support for the National ACEL Leadership Conference is also greatly appreciated.

ACEL's extensive online resource centre has enabled increased access to quality publications for ACEL members across NSW. ACEL NSW membership continues to increase in both metropolitan and regional areas as educators across the state become aware of the breadth and quality of ACEL publications and professional learning.

#### Awards and recognition

The ACEL NSW awards and recognition program has been further strengthened with the 2019 Awards program drawing together over 185 educators in the recognition of professional excellence. Senior educators from all sectors joined the NSW Minister for Education in acknowledging award recipients. This year five educational leaders from NSW were inducted as ACEL NSW Fellows. Six outstanding early career leaders received the Mary Armstrong Award for Teacher Leadership and fifteen ACEL NSW Leadership Awards were granted to individuals and school teams that have made a significant impact on student learning. The ACEL NSW Awards committee also conferred the Patrick Duignan Award for outstanding leadership to Dr Norman McCulla and this year I was honoured to receive the NSW ACEL Dr Paul Brock Memorial Medal. The NSW ACEL Media Award was granted to Dr Stan Grant in recognition for his achievements as a journalist, educator and advocate who has recast the gap between Indigenous and non-Indigenous Australians as a place for a national conversation that is deeper more powerful and more hopeful. In his acceptance address Stan provided us with a powerful insight into the Waradjuri focus for each of us to "live respectfully in a world worth living in."

ACEL NSW remains committed to ensuring high quality professional learning, publications and advocacy. Strong university partnerships with ACEL NSW will be critical in further developing our connections between research and practice. ACEL NSW will continue to create exciting opportunities to ensure the provision of excellent professional learning, focused well researched publications and strong advocacy for the profession.

As a smaller jurisdiction, ACEL's focus on networking and collaboration, positions the association as a key player in supporting and strengthening Northern Territory educational leaders. In 2019 the Northern Territory branch has achieved their aspirations of expanding ACEL's local footprint; increasing crosssectoral and regional membership and supporting Northern Territory Leaders' voice and agency at both a local and National level.

This success has been achieved through the work of a dedicated, passionate and diverse branch executive, comprised of a remote principal, experienced and early career school leaders, system leaders and new voice scholars. Current membership numbers are the highest that the Northern Territory branch has ever seen.
